WHEREAS: The Ponca Tribe of Nebraska is a federally recognized Indian Tribe (P.L. 101-484) whose business affairs are conducted by the Ponca Tribal Council as defined in the Constitution approved July 22, 1994 by the Acting Deputy Commissioner of Indian Affairs; and

WHEREAS: Pursuant to the Constitution of the Ponca Tribe of Nebraska, the Ponca Tribal Council exercises legislative powers to enact and promulgate resolutions and ordinances subject to all express restrictions upon such powers contained in the constitution; and

WHEREAS: The Ponca Tribal Council has reviewed the proposed amendments to the Ponca Tribe of Nebraska Law & Order Code Title XVI – Liquor Control; and

WHEREAS: The proposed amendments are being considered in response to suggested and required changes from the BIA as part of the federal requirement that the liquor ordinance be approved by BIA and published in the federal register. These amendments are required for the liquor ordinance to be approved and made valid; and

WHEREAS: The proposed amendment to the Law & Order Code Title XVI Liquor Control was placed on the July 6, 2018 Tribal Council Agenda to allow comments from the public with First Reading also held that same date; and on July 21, 2018 for the second reading and approval thereof. A notice of intent to amend the Law & Order Code Title XVI – Liquor Control was mailed to all heads of household at least 14 days prior to any final action satisfying the requirements for the adoption, amendment, or abolishment of Ordinances.

THEREFORE BE IT RESOLVED that the Ponca Tribal Council approves the amendments to the Ponca Tribe of Nebraska Law & Order Code Title XVI – Liquor Control.

BE IT FURTHER RESOLVED that these amendments shall take effect immediately.

WHEREAS: The purpose of the Maternal and Child Health contract is to improve the health of Nebraska's Native American mothers, infants, children (including children with special health care needs), and adolescents. Specific activities are identified in the plan of activities as set forth in the 2018 Work Plan.

THEREFORE BE IT RESOLVED That the Ponca Tribal Council approves the contract with the Nebraska Department of Health and Human Services, Division of Public Health Lifespan Health Services Unit for the period of April 1, 2018 through March 31, 2019.
