WHEREAS: The Ponca Tribe of Nebraska is a federally recognized Indian Tribe (P.L. 101-484) whose business affairs are conducted by the Ponca Tribal Council as defined in the Constitution approved July 22, 1994 by the Acting Deputy Commissioner of Indian Affairs; and

WHEREAS: Pursuant to the Constitution of the Ponca Tribe of Nebraska, the Ponca Tribal Council exercises legislative powers to enact and promulgate resolutions and ordinances subject to all express restrictions upon such powers contained in the constitution; and

WHEREAS: The Ponca Tribal Council has reviewed the proposed amendment to the Ponca Tribe of Nebraska Law & Order Code, Title I – General Provisions, Section 1-7-5.

WHEREAS: The proposed amendment to the Law & Order Code, Title I was placed on the October 8, 2018 Tribal Council Agenda to allow comments from the public and on October 28, 2018 and November 5, 2018 for first and second readings respectively. A notice of intent to amend the Law & Order Code, Title I was mailed to all heads of household at least 14 days prior to any final action satisfying the requirements for the adoption, amendment, or abolishment of Ordinances.

THEREFORE BE IT RESOLVED that the Ponca Tribal Council approves to amend the Ponca Tribe of Nebraska Law & Order Code, Title I – General Provisions, Section 1-7-5.

BE IT FURTHER RESOLVED that these amendments shall take effect immediately.

# LAW AND ORDER CODE REVISION TITLE I GENERAL PROVISIONS

Discussion on October 8, 2018 During Tribal Council Meeting

\*\*\*\* NOTICE: All Tribal Members\*\*\*\*

The Ponca Tribal Council will be reviewing a proposed amendment to the Law and Order Code, Title I – General Provisions, Section 1-7-5 Recognition of Foreign Court Orders/Judgments.

Our current lender and likely all future phase lenders will have an issue with the current language of the L&O Code regarding the enforcement of foreign judgments. In particular, current tribal law states that foreign judgments (i.e. other tribal courts, state courts or federal courts) will be enforced by the Ponca tribal courts as long as, among other things, such judgments don't violate the "public policy of the Ponca Tribe." This standard is too broad and would allow the Tribal Courts to refuse to enforce any judgment it doesn't agree with.

Rather than repealing and replacing this section, our lender is proposing adding an additional subsection which would allow the Tribal Council, by resolution, to waive application of this language. Such resolutions would be entered into as closing conditions of certain loans, including the upcoming Shakopee loan. Thus, we propose adding the following to Section 1-7-5 as #3 to the existing Law & Order Code:

(\_\_\_\_). Nothing in this subsection shall prevent the Tribal Council, by duly executed Tribal Council Resolution, from making the foregoing provisions not applicable to any transaction, agreements, or other matter specified in such Tribal Council Resolution.

There will be a discussion by Tribal Council that is open for public comment on October 8, 2018 at 10:00 a.m. or as soon thereafter as it may be heard.
