### APPROVAL TO UTILIZE IHBG FUNDS AS LEVERAGE FOR 2018 INDIAN COMMUNITY DEVELOPMENT BLOCK GRANT (ICDBG) PROJECT

**WHEREAS**, the Tribal Council of the Ponca Tribe of Nebraska has designated the Northern Ponca Housing Authority (NPHA) as its Tribally Designated Housing Entity by Tribal Council Resolution No. 97-67; and

WHEREAS, tribes and tribal organizations are eligible recipients of funding made available to improve the nation's housing for Native American people from the U.S. Department of Housing and Urban Development (HUD) through its Indian Community Development Block Grant (ICDBG) Program; and

**WHEREAS,** the NPHA has been authorized by the Tribal Council of the Ponca Tribe of Nebraska and the Bureau of Indian Affairs to apply for an ICDBG as a Tribal Organization and Tribally Designated Housing Entity; and

**WHEREAS**, the NPHA has been designated the Northern Ponca Housing Resident Association as the Community Based Development Organization (CBDO) to undertake the New Housing Construction activities; and

WHEREAS, the NPHA Board of Commissioners has identified the need for new construction activities and has selected the ICDBG as the best program for moving forward with future development planning activities for an elder/disabled complex in the Omaha service area; and

WHEREAS, the Board of Commissioners of NPHA, as appointed by the Tribal Council of the Ponca Tribe of Nebraska, is submitting a 2018 ICDBG proposal requesting \$800,000 for new housing construction activities; and

WHEREAS, the NPHA Board of Commissioners has identified \$185,000 in future Indian Housing Block Grant (IHBG) funds to be utilized as leverage and donated land purchased in December 2018 appraised at \$90,000 as additional leverage in its 2018 ICDBG new housing construction activities project and

WHEREAS, the NPHA Board of Commissioners certifies that the NPHA will continue to be responsible for the ongoing maintenance of the future new housing construction units according to its operations and maintenance policy, and will secure assurances from tenants that they will complete light maintenance and upkeep as specified in individual Lease Agreements; and assures that all new construction activities will be constructed within three years; and

**WHEREAS,** the NPHA Board of Commissioners certifies that the NPHA has adopted Housing Standards as specified in Section I.A.4 of the 2018 ICDBG NOFA; and

THEREFORE, BE IT RESOLVED, that the Board of Commissioners of the Northern Ponca Housing Authority has reviewed and understands the requirements of the ICDBG program and authorizes the NPHA Executive Director to prepare and submit an ICDBG application for FY 2018; and

**BE IT FURTHER RESOLVED** that the Northern Ponca Housing Authority Board of Commissioners is authorizing the use of a total of \$185,000 in Indian Housing Block Grant (IHBG) funds, spread over three years (\$61,667 each year from FY 2019 through FY 2021), to be utilized as leverage, as well as the value of the appraised donated land, for the ICDBG project to begin and complete new housing construction activities for low and moderate income elders and disabled Native Americans.
