WHEREAS: The Ponca Tribe of Nebraska is a federally recognized Indian Tribe (P.L. 101-484) whose business affairs are conducted by the Ponca Tribal Council as defined in the Constitution approved July 22, 1994 by the Acting Deputy Commissioner of Indian Affairs; and

WHEREAS: Pursuant to the Constitution of the Ponca Tribe of Nebraska, the Ponca Tribal Council exercises legislative powers to enact and promulgate resolutions and ordinances subject to all expenses restrictions upon such powers contained in constitution; and

WHEREAS: Article 1 of the Ponca Tribe of Nebraska's Constitution affirms, "the territorial jurisdiction of the Ponca Tribe of Nebraska under [their] Constitution shall extend to all trust or tribal lands and as described by metes and bounds in the Treaties heretofore ratified by the Congress of the United States of America and shall cover all future additions that are within or without said boundary lines that may be acquired by the Ponca Tribe of Nebraska...regardless if the eligible lands are under the control of the Ponca Tribe of Nebraska at the time of the adoption of [their] Constitution; and

WHEREAS 23 U.S.C. § 204 (b) (2), as amended by the Fixing America's Surface Transportation Act (FAST Act), Pub. L. 114-94 (December 4, 2015),, and the Delegations of Authority set forth in 25 U.S.C. §§ 1, 1a, and 2, provides that an Indian Tribe can enter into a Tribal Transportation Program (TTP) Agreement with the Department of the Interior, Bureau of Indian Affairs; and

WHEREAS the Agreement will authorize the Tribe to perform the planning, research, design, engineering, construction, and maintenance of highway, road, bridge, parkway, or transit facility programs or projects that are located on or which provide access to the Ponca Tribe of Nebraska Service Delivery Area that are eligible for funding pursuant to 23 U.S.C § 202 and 25 CFR Part 170 (TTP regulations); and

WHEREAS the (Tribe) hereby is notifying the Bureau of Indian Affairs that they wish to enter into a Tribal Transportation Program (TTP) Agreement; and

NOW, THEREFORE, BE IT RESOLVED that the Ponca Tribe of Nebraska Tribal Council hereby authorizes the Bureau of Indian Affairs to take the necessary action to execute a Tribal Transportation Program (TTP) Agreement; and

BE IT FINALLY RESOLVED that the Ponca Tribe of Nebraska Tribal Council is authorized to enter into, negotiate, and execute a Tribal Transportation Program (TTP) Agreement, Referenced Funding Agreement, Retained Services Addendum, and that the Tribal Transportation Program (TTP) Agreement shall extend for the maximum period authorized by any statutory extensions to the FAST Act. In the event the FAST Act is reauthorized in whole or in part, this agreement shall continue to the extent authorized by law until a successor agreement is negotiated by the Ponca Tribe of Nebraska.
