Reel Mentors event provides learning and fun

On Saturday, June 26th District 2 collaborated with the Reel Mentors Program founders Ronald Suverkrubbe, Ponca Tribal member and owner of Critter U. and Rashad Evans, Hall of Fame mixed martial artist, to provide a fishing event for our district youth at Standing Bear Lake off of 138th and Fort in Omaha, NE. Many of the Reel mentor representatives traveled from Florida to attend the event and even brought a few youth from the FL area to experience life in Omaha and fishing in Nebraska. Also in attendance were many of the Osni Ponka youth council members to serve as mentors for the day.

The group met in the morning to provide fishing education for the youth. They learned how to tie different fishing knots, how to cast, and about fishing techniques.



The youth were able to have casting contests and see fish up close to better understand the sport. Once the group was finished with donuts and the education session, they walked down to the pier to show their new skills with their mentors. After fishing for a couple of hours, the group reconnected at the pavilion for a grill out and the kids were able to play games and hang out with their mentors. In addition to the fishing, learning, and playing, the participants had the opportunity to engage with champions Rashad Evans and Houston Alexander. Their stories provide meaningful

examples for youth of the power of goals, discipline, effort, and the ability to cope with stress and pressure. Both gentlemen are committed to "giving back" and strengthening our communities and empowering our youth.

The Reel Mentors collaboration made the day successful for our D2 Ponca youth, with Scheels providing the fishing poles for each youth to take home. D2 Tribal Council provided the food, tackle boxes with goodies, and the prizes for the youth contests.

According to Ponca member Ronald Suverkrubbe, "the goals of the Reel Mentors programs are simple ... to teach kids how to fish and provide each child with a mentor they can talk to about education, life ... and of

They were chaperoned by the Osni Ponka Youth Council advisor, Rebecca Sullivan, and Ponca member, Candy Schott. At the conference our Ponca Youth Council members learned about native pride, raising awareness on important topics that are affecting our native youth, and heard from numerous guest speakers. Their favorite guest speaker was Lauren Schad, Lauren is 26 years old, and she is a member of the Cheyanne River Sioux Tribe. Lauren is a professional volleyball player for a team in France. She shared her experience about teaching others about her culture, being a minority, persevering through school, and accomplishing goals as a young native. She is a Nike N7 Ambassador and has a line coming out early this month. Our members loved hearing



about her commitment as a young Native athlete in school and raising awareness on the MMIW epidemic. Another highlight from the trip was being exposed to various cultures and traditions in other tribes. The Youth Council members especially enjoyed learning about other regions around the United States. At this conference, youth spoke from the Great Plains, Midwest, Northeast, Northwest, Pacific, Rocky Mountains, Southeast, Southern Plains, Southwest, and Western regions. It was great for our Youth Council members to hear what different Youth Councils are doing, their perspectives, and about life in their tribes. Our

Youth Council members have even learned that they can stay in touch with everyone at Unity through a new app called "Unity Wellness Warrior". Our members have downloaded this app and through it, they can learn about culture, language, traditional dishes, project planning, financial fitness, and more. This will allow our tribe's Youth Council to stay in touch and communicate with other youth leaders around the United States. Together, we hope to continue to raise awareness on important issues and inspire future leaders to be anything they set their minds to.

Learning about the different types of ozone

There are two types of ozone around the Earth. One is harmful groundlevel ozone. Ground-level ozone has been linked to severe health complications such as a decrease in lung functions, inflammation, and increases in asthma attacks. Groundlevel ozone is produced when volatile organic compounds (commonly found in aerosol sprays) react with nitrogen and radiation from sunlight.

The other type of known ozone is the protective layer of ozone in the

atmosphere. The ozone layer is a layer of the atmosphere that protects the Earth from harmful ultraviolet radiation. The ozone layer has been depleted over the years thanks to industrialization, with the major releases of greenhouse gases from large factories. Due to the depletion of the ozone layer, the number of cases of different types of skin cancer has been on the rise. Sunburns have also gotten worse over the years. This is because more harmful ultraviolet radiation from the sun is making its way to the Earth's surface.

Thankfully, according to the World Meteorological Organization (WMO) on January 6th of this year, they declared that the Antarctic ozone hole, which was one of the deepest and largest gaps in the last 40 years has now closed.

September 16, 2021, marks the 34th year of what is now known as World Ozone Day. World Ozone Day is a day marked to bringing awareness to protecting the World's ozone layer in the atmosphere. This started thanks to the Vienna Convention

for the Protection of the Ozone Layer and the Montreal Protocol. The Vienna Convention was the scientific confirmation that the ozone layer had been depleted and prompted the international community to take actions against the depletion of the ozone layer. The Montreal Protocol is a world protocol on how to protect the ozone layer. This is done by taking measures to control the releases of greenhouse gases and other substances that harm the ozone layer.

Ponca Health Services presents on summer storm preparedness

On Thursday, July 22nd, the Ponca Tribe of Nebraska hosted a Summer Severe Weather preparedness event. Staff presented on how to make an emergency plan for severe weather, and talked about assembling an emergency kit for these scenarios. In-person and virtual attendees were invited to pick up some basic emergency kit supplies, and all attendees were entered into a drawing for larger emergency kit supplies. Winners of the raffle included Beth Barger, Candace Schmidt, Jamie Lemus, and Tasia Voss.

Make sure that you and your family are prepared for summer storms!



Why build an emergency kit?

After an emergency, you may not have access to running water, electricity, or even your home, and may need to survive with limited resources

for several days. Being prepared means having enough food, water, and other supplies. Generally, plan for three days, possibly longer if you are in a remote or hardto-reach area. Once you take a look at the basic items, consider what unique needs your family might have, such as supplies for pets or seniors. Include copies of important paperwork such as birth certificates, titles and deeds, and insurance information.

PONCA TRIBE OF NEBRASKA TRIBAL COUNCIL

RESOLUTION 21-42.

WHEREAS: The Ponca Tribe of Nebraska is a federally recognized Indian Tribe (P.L. 101-484) whose business affairs are conducted by the Ponca Tribal Council as defined in the Constitution approved July 22, 1994 by the Acting Deputy Commissioner of Indian Affairs; and

WHEREAS: Pursuant to the Constitution of the Ponca Tribe of Nebraska, the Ponca Tribal Council exercises legislative powers to enact and promulgate resolutions and ordinances subject to all express restrictions upon such powers contained in the constitution; and

WHEREAS: Federal law prohibits the sale, possession, and introduction of liquor in Indian country unless, pursuant to 18 U.S.C. § 1161, such sale, possession, or introduction is, among other things, in conformity with an ordinance duly adopted by the tribe having jurisdiction over such area of Indian country; and

WHEREAS: The Ponca Tribe Council enacted an ordinance governing liquor in Indian country of the Tribe as Title XVI of the Ponca Tribe of Nebraska Code on July 21, 2018; and

WHEREAS: Federal law, pursuant to 18 U.S.C. § 1161, requires that a liquor ordinance adopted by an Indian tribe must be certified by the Secretary of the Interior and published in the Federal Register; and

WHEREAS: The Secretary of the Interior approved the Tribe's enacted liquor ordinance on August 9, 2018 and published the liquor ordinance in the Federal Register on September 11, 2018; and

WHEREAS: Since the enactment and approval of the Tribe's liquor ordinance, the Tribe has found certain amendments are needed to clarify activities and persons subject to licensing and regulation, provide more consistent language on activities regulated, and better define the activities permitted by a liquor license as well as to allow the Liquor Board to more appropriately handle licensing and enforcement without the need for legislative intervention; and

WHEREAS: The proposed amendments to the Law & Order Code – Title XVI Liquor Control were placed on the June 15, 2021 Tribal Council agenda to allow comments from the public with First Reading held on June 22, 2021, and on July 6, 2021 for second reading and approval thereof. A notice of intent to amend the Law & order Code Title XVI – Liquor Control was mailed to all heads of household at least 14 days prior to any final action satisfying the requirements for the adoption, amendment, or abolishment of Ordinances.

THEREFORE, BE IT RESOLVED that the Ponca Tribal Council requests that the amended Title XVI, Liquor Control, be certified by the Secretary of the Interior and published in the Federal Register in accordance with 18 U.S.C. § 1161.

BE IT FURTHER RESOLVED that the Chairman or his designee is authorized to take any actions and execute any documents necessary or required to carry out this Resolution.

MEMBERS NEEDED!

LAW & JUSTICE COMMITTEE

There is currently an open position for a Ponca Tribal member and a member from the legal area. The duties of this committee are as follows:

- a. To act as a liaison between the Tribal Court and Tribal Council;
- b. To oversee the budget of the Tribal Court and make recommendations to the Tribal Council regarding the same;
- c. To provide oversight of the Tribal Court and make recommendations to the Tribal Council relating to the operations and growth of the Court, including additional dispute resolution methods;
- d. To review complaints of judicial misconduct or disability under the Code of Judicial Conduct or other applicable rules or statutes of conduct governing the Judges and Justices of the Tribal Court, hold public fact-finding hearings when such complaints are supported by probable cause with the Judge or Justice given a full opportunity to defend and be heard with legal counsel and, if such hearing reveals clear, cogent and convincing evidence of a violation, to publicly admonish, reprimand or censure the Judge or Justice or recommend suspension or removal from office in accordance with the laws of the Tribe;
- e. To make recommendations on amendments to the Rules of Court to the Tribal Council and establish such rules in the absence of Tribal Council action as permitted herein;
- f. To approve Rules of Court governing or related to judicial conduct as provided herein;
- g. To set filing fees for the Tribal Court as permitted herein;
- h. To provide annual evaluations of the Judges and Justices of the Tribal Court and provide the same to the Tribal Council and members of the Tribe;
- i. To make recommendations to the Tribal Council regarding amendments, modifications, and additions to this Code; and
- j. Such other duties and responsibilities as the Tribal Council may from time designate.

LANGUAGE & CULTURE COMMITTEE

There is currently an open position for District 4 on the Language & Culture Committee for a term to expire on 3/9/24. Some of the responsibilities of this committee are:

- To provide guidance to the Culture Department and Language Program with long-term planning, programming, and the use of traditional knowledge.
- To generate culturally-appropriate programming to increase tribal involvement on culture and language activities and create a sustainable culture and language program for tribal members inside and outside the SDAs.
- To act as a resource for Tribal departments to create culturally-based programming by providing guidance, knowledge, wisdom, and expertise on Ponca culture, traditions, history, and beliefs.
- To assist the Ponca Tribal government in the formulation of policies and procedures pertaining to the Ponca Language, culture, and history.
- To review and approve all Ponca culturally related educational material, such as instructional materials and modern communication media productions, to be used to provide instruction to
- To review and reserve approval on all other activities and tasks related to the Ponca language, history, and culture as may be referred the Committee.
- To periodically assess and review the Language Program and provide such assessments to the Tribal Council.


