WHEREAS: Pursuant to the Constitution of the Ponca Tribe of Nebraska, the Ponca Tribal Council exercises legislative powers to enact and promulgate resolutions and ordinances subject to all express restrictions upon such powers contained in the constitution; and

WHEREAS: The Ponca Tribe of Nebraska wishes to join the National Indian Gaming Association for the year 2022; and

WHEREAAS: NIGA is an inter-tribal association of federally recognized tribes, communities, rancherias, colonies, pueblos, bands, nations, or other federally recognized tribal groups or communities of Indians ("Tribe" herein); and

WHEREAS: The primary purposes are:

- 1. To promote, protect, and preserve the general welfare and interest of Indian gaming tribes through the development of sound policies and practices with respect to the conduct of gaming activities in Indian Country;
- 2. To assist in the dissemination of information to the Indian gaming community, federal government, and the general public on issues related to the conduct of gaming in Indian Country;
- 3. To preserve and protect the integrity of gaming in Indian Country;
- 4. To maintain, protect, and advocate Indian tribal sovereignty; and

WHEREAS: The Ponca Tribe of Nebraska meets all the requirements for Tribal Membership pursuant to Part 5, "Classes Qualifications, and Rights of Membership," of the NIGA Bylaws.

THEREFORE, BE IT RESOLVED that the Ponca Tribe of Nebraska authorizes the payment of dues for NIGA Tribal Membership of \$3,500.00; and
