WHEREAS: The purpose of the Tribal Transportation Program is to provide safe and adequate transportation and public road access to and within Indian reservations, Indian lands, and Alaska Native Village communities. Funds from TTP will fund general operating expenses for the Ponca Tribe of Nebraska's Transit Department.

THEREFORE, BE IT RESOLVED that Stephanie Geery-Zink, Grants Manager, is authorized to apply for, execute and file an application for federal assistance on behalf of the Ponca Tribe of Nebraska with the U.S. Department of Transportation.

BE IT FURTHER RESOLVED that Stephanie Geery-Zink is authorized to execute and file with its applications the annual certifications and assurances and other documents the U.S. Department of Transportation requires before awarding a federal assistance grant or cooperative agreement.

WHEREAS: The Ponca Tribe of Nebraska is a federally recognized Indian Tribe (P. L. 101-484) whose business affairs are conducted by the Ponca Tribal Council as defined in the Constitution approved July 22, 1994 by the Acting Deputy Commissioner of Indian Affairs; and

WHEREAS: Pursuant to the Constitution of the Ponca Tribe of Nebraska, the Ponca Tribal Council exercises legislative powers to enact and promulgate resolutions and ordinances subject to all express restrictions upon such powers contained in the Constitution; and

WHEREAS: Article V, Section 1(a) of the Constitution provides that the Ponca Tribal Council has the power to negotiate with the federal government on behalf of the Tribe; and

WHEREAS: Pursuant to Public Law 93-638 or the Indian Self-Determination and Education Assistance Act ("ISDEAA"), 25 U.S.C. §§ 5301 et seq., the Ponca Tribe of Nebraska has entered into a self-determination contract with the Bureau of Indian Affairs ("BIA"), United States Department of Interior, to include the Consolidated Tribal Government Program ("CTGP") which includes programs and funding for Administration, Appellate Court, Buffalo, Child Welfare, Culture, Education, Enrollment, Land Management, Tribal Court, Workforce Development; and

WHEREAS: the Ponca Tribe of Nebraska wishes to continue contracting with the BIA for CTGP for another fiscal year ending September 30, 2023 and the Ponca Tribal Council has before it a proposed budget and other documents for the programs that are part of the CTGP for the fiscal year ending September 30, 2023.

THEREFORE BE IT RESOLVED that the Ponca Tribal Council hereby approves the proposed budget and other documents for the programs that are part of the CTGP for the fiscal year ending September 30, 2023.

BE IT FURTHER RESOLVED that the Ponca Tribal Council hereby approves submission of the application for CTGP for the fiscal year ending September 30, 2023 and wishes to enter into a Public Law 93-638 contract for these funds.

BE IT FURTHER RESOLVED that the Ponca Tribal Council hereby authorizes the Chairman and Secretary to sign and execute all contracts, documents, proposals, assurances, and other documents necessary to carry out this Resolution, provided that any final Public Law 93-638 contract shall first being subject to the approval of the Ponca Tribal Council.
