WHEREAS: Pursuant to the Constitution of the Ponca Tribe of Nebraska, the Ponca Tribal Council exercises legislative powers to enact and promulgate resolutions and ordinances subject to all express restrictions upon such powers contained in the constitution; and

WHEREAS: The Tribe has the authority to submit an application on behalf of the Native American individuals in the Tribe and to administer programs and activities under this program; and

WHEREAS: The Federal Emergency Management Agency's (FEMA) mission is helping people before, during and after disasters and hazard mitigation. FEMA administers the Building Resilient Infrastructure and Communities program (BRIC); and

WHEREAS: BRIC will support states, local communities, tribes and territories as they undertake hazard mitigation projects, reducing the risks they face from disasters and natural hazards; and

WHEREAS: The BRIC program building principles are supporting communities through capability-and capacity-building; encouraging and enabling innovation; promoting partnerships; enabling large projects; maintaining flexibility; and providing consistency; and

WHEREAS: The objective of this funding opportunity is to prepare the Ponca Tribe of Nebraska with hazard mitigation projects in the Service Delivery Area.

THEREFORE, BE IT RESOLVED that the Grants Manager, Stephanie Geery-Zink, is approved to submit the application for funding administered by FEMA on behalf of the Ponca Tribe of Nebraska.
